Day 1: Monday, September 13, 2027 • Depart

Our Italian adventure begins as we board our international flight bound for the Eternal City of Rome. **Inflight Meals**

Day 2: Tuesday, September 14, 2027 • Rome

Upon arrival in Rome, we are greeted by our tour director and motor coach for a panoramic introduction to the city. We pause for lunch before checking into our hotel. This afternoon we explore ancient Rome with a local guide, on our walking tour of the Palatine and Capitoline Hill. We tour the Colosseum and walk through the Roman Forum, where the ruins of 2,000 years ago still come to life. We admire the Arch of Constantine and visit San Pietro in Vincoli to see Michelangelo's *Moses*. Tonight, we gather for a festive Welcome Dinner, toasting the journey ahead. **D**

Day 3: Wednesday, September 15, 2027 • Rome

This morning a local guide takes us on a tour of the Vatican Museums, including the Sistine Chapel. We also visit St Peter's Basilica. We continue to the vibrant neighborhoods surrounding the Spanish Steps and Piazza Navona, known for their lively streets, fountains, and artistic energy. This evening, we gather near the Trevi Fountain for dinner at a traditional trattoria, savoring appetizers, fresh handmade pasta, main courses, and homemade desserts. **B, D**

Day 4: Thursday, September 16, 2027 • Montecatini Terme

This morning, we take the fast train to Florence, where a local guide introduces us to the city's artistic and architectural treasures, including the Baptistery, Giotto's Tower, the Pitti Palace, and the Accademia - home to Michelangelo's incomparable *David*. We explore the bustling San Lorenzo

Leather Market and the shops along the Ponte Vecchio before continuing to Montecatini Terme, where we check into our hotel for the next three nights. **B,D**

Day 5: Friday, September 17, 2027 • Montecatini Terme

Our sightseeing today includes a visit to the famous Leaning Tower of Pisa, followed by a lunch break in the charming walled city of Lucca. Known for its Renaissance-era ramparts and peaceful, pedestrian-friendly streets, Lucca offers a delightful glimpse into Tuscan life. We return to Montecatini this afternoon and have the balance of the day free to relax and enjoy this city, world-renowned for its spas and wellness culture. **B**

Day 6: Saturday, September 18, 2027 • Montecatini Terme

Today we journey to the Ligurian coast for an unforgettable excursion to Cinque Terre, a series of colorful fishing villages clinging to rugged seaside cliffs. We begin with a scenic boat ride along the sparkling sea, then continue by train and on foot, strolling along the famed Via dell'Amore (Lovers' Lane) with breathtaking views of the coastline. As we explore the villages, we observe the unique character of local life, from the fishermen at work to the charming homes they return to each day. We have dinner in Venice then return to the mainland and check into our hotel **B**

Day 7: Sunday, September 19, 2027 • Venice

We travel north to Venice, where canals replace streets and gondolas glide silently beneath arched bridges. After lunch on our own, we are introduced to the city with a guided tour of St. Mark's Square, including its grand basilica and bell tower, followed by a cruise along the Grand Canal. We check into our hotel and enjoy dinner together this evening. **B/D**

Day 8: Monday, September 20, 2027 • Como

Our journey continues north to Verona, the city of Romeo and Juliet. A local guide leads us on a walking tour featuring the Roman Arena, Bra Square, Juliet's Balcony, and the lively Erbe Square. We enjoy lunch on our own. After soaking in the historic atmosphere, we continue to the shores of Lake Como, where we check into our hotel amid stunning alpine and lakeside scenery. **B/D**

Day 9: Tuesday, September 21, 2027 • Como

This morning, we board a hydrofoil for a leisurely cruise across Lake Como's sparkling waters to Bellagio, the "Pearl of the Lake." Enjoy time exploring its charming lanes, elegant villas, and boutique shops before continuing by ferry to Villa Balbianello, a masterpiece of 18th-century architecture with terraced gardens and cinematic views—featured in Casino Royale and Star Wars: Episode II. We return to Como for a relaxing afternoon and evening to enjoy the lakeside ambiance. **B/D**

Day 10: Thursday, September 22, 2027 • Como

Enjoy a full day at leisure in Como. Stroll the lakeside promenade, explore charming streets and shops, or simply relax and soak in the beauty of Lake Como at your own pace. **B**

Day 11: Friday, September 23, 2027 • Return

We drive to Milan Airport and board our return flights home, filled with memories of Italy's beauty, history, and flavors. **B**

Payment Schedule:

A deposit of \$500 per person is due with reservation.

A 2nd deposit of \$1,000 is due March 17, 2027.

Final payment is due June 15, 2027.

Invoice will be sent out prior to final payment. Passengers may add after this date subject to air and land availability. Generally airlines do not increase the price of a ticket after it has been contracted. However, prior to the issuance of a ticket, airlines may (and regularly do) impose fuel, tax, or security surcharges. In the event a surcharge is imposed after Ed-Ventures has received a final payment, Ed-Ventures will send an additional invoice for the surcharge amount. Early registration is encouraged.

Insurance:

Purchase of health, baggage, and trip cancellation and interruption insurance is strongly recommended. Cost is 7.2% of the trip. This insurance is non-refundable and to qualify for pre-existing conditions, must be purchased at time of deposit.

Currency:

Currency exchange rates fluctuate constantly. In the event of a significant drop in the value of the dollar, we reserve the right to add a currency surcharge to the price of the tour.

Refund/Cancellation Policy:

All cancellations must be in writing. The date of postmark will determine the amount of refund due. Refunds are based on the number of days prior to departure date. From the time of deposit to 120 days before departure a \$100 administrative fee plus any airfare penalties will be assessed. From 119-46 days, a \$300 cancellation penalty plus lost airfare deposits and any unrecoverable deposits to ground suppliers will be assessed. Airline tickets once purchased are nonrefundable. Anyone canceling 45 days or less prior to departure will receive **no refund**.

Terms and Conditions

We reserve the right to cancel this trip due to lack of subscription. In the event of cancellation of the trip in its entirety, a full refund of all deposits will be made to passengers enrolled at the time of cancellation.
