**DAY 1: Thursday, September 26, 2024 • Departure**  
Our journey begins as we board our flight to Thessaloniki, Greece. **B, L**

**DAY 2: Friday, September 27, 2024 • Thessaloniki**  
Upon arrival at the airport in Thessaloniki, we meet our guide and transfer to our hotel for a welcome dinner and an overnight. **D**

**DAY 3: Saturday, September 28, 2024 • Thessaloniki**  
This morning we explore Thessaloniki. We drive along the waterfront to the massive White Tower and nearby Triumphant Arch of Galerius, built in 303 AD. We see St. Demetrio's Church with its valuable mosaics and frescoes. Then, we drive to the upper town for a marvelous view of the city. The site where the monastery of Vlatadon was built is believed to be the location where Jason's House once stood and where Paul was accommodated during his visit to Thessaloniki. Later we sample the wines of a local winery. **B, L**

**DAY 4: Sunday, September 29, 2024 • Thessaloniki, Kavala, Philippi**  
After breakfast we board our coach and drive to Philippi, the first city in Macedonia to hear the gospel. Then we continue to Kavala (Neapolis) where Paul landed in Europe. We visit a local winery. The area has a long tradition of fine wines with its roots in antiquity, cultivated in a variety of grapes, the "Books of Vine", from which they produced the famous "Biblical wine". We learn about the wines produced here and enjoy lunch. Then we visit

Lydia's Baptistery, where the first woman was baptised on European soil. We return to Thessaloniki where dinner is on our own. **B, L**

**DAY 5: Monday, September 30, 2024 • Thessaloniki-Meteora**

After breakfast we depart for Vergina to see the famous Royal Tombs. Then we proceed to Rapsani Winery near the Tembi Valley at the slopes of Olympus, in hilly and mountainous terrain. We sample some of the red wines and visit the Vine Museum which highlights the local history of Rapsani, which has been linked over the last three centuries with the cultivation of the vine and the production of the famous rapsanian brass. We end the day in Meteora. **B, D**

**DAY 6: Tuesday, October 1, 2024 • Athens**

This morning we explore the Meteora monasteries, perched precariously on summits of grey rocks pinnacles of varied and beautiful shapes. The monasteries date back to the 14<sup>th</sup> century when the monks sought refuge in the cliff side caves and then fled higher to build the original wooden shelter, later transformed into monasteries. Afterwards we drive to Athens stopping to ponder the history of the 300 Men in Thermopylae. We overnight in Athens. **B, D**

**DAY 7: Wednesday, October 2, 2024 • Athens**

This morning we explore the ruins of the Parthenon, the Erechtheum and the Propylae. Then we proceed to Mars Hill where Paul spoke to the ancient Athenians about the true God (Acts 17:22-34). By the House of Parliament on Syntagma Square we see the Evzones in their distinctive

uniforms guarding the Presidential palace and the Tomb of Unknown Soldier. We also see the Library, the University, the Temple of Olympian Zeus, Hadrian's Arch, and the Panathenaic Stadium where the first Olympic Games were held. This afternoon we explore some of the best wineries of Athens. Tonight, we have dinner looking out at the Parthenon. **B, D**

#### **DAY 8: Thursday, October 3, 2024 • Athens-Corinth**

After breakfast, we drive to Corinth with a short stop to marvel at the Corinth Canal. The town of Corinth was the site of extensive ministry to fledgling and beloved Christian community. We spend the afternoon exploring two of the best wineries in the Nemea region. We return to Athens where dinner is on our own. We return to Athens for overnight. **B, D**

#### **DAY 9: Friday, October 4, 2024 • Santorini**

This morning we transfer to Piraeus Port and take the ferry to Santorini. Upon arrival we visit Akrotiri and tour the museum with the Akrotiri frescoes. We have some free time in Fira. Later we return to our hotel this afternoon to enjoy a free evening in Oia. **B**

#### **Day 10: Saturday, October 5, 2024 • Santorini**

Today is devoted to exploring the wines and wineries of the island. This evening we take a sunset cruise with buffet on board. **B, D**

#### **Day 11: Sunday, October 6, 2024 • Santorini**

Today is a free day to experience and explore the island on our own. **B, D**

#### **Day 12: Monday, October 7, 2024 • Santorini to Athens**

We transfer to the airport for an early morning flight to Athens. We have free time to explore. Tonight, we enjoy dinner and a Zafero Experience. **B, D**

#### **Day 13: Tuesday, October 8, 2024 • Return to USA**

Our journey has come to an end as we transfer to the airport for our return flight home.

#### **Payment Schedule:**

A deposit of \$800 per person is due with reservation by January 20, 2024. Interim payment of \$1,500 per person is due March 31, 2024. Final payment is due May 31, 2024. Invoice will be sent out prior to final payment. Passengers may add after this date subject to air and land availability. Generally airlines do not increase the price of a ticket after it has been contracted. However, prior to the issuance of a ticket, airlines may (and regularly do) impose fuel, tax, or security surcharges. In the event a surcharge is imposed after Ed-Ventures has received a final payment, Ed-Ventures will send an additional invoice for the surcharge amount. Early registration is encouraged.

#### **Currency:**

Currency exchange rates fluctuate constantly. In the event of a significant drop in the value of the dollar, we reserve the right to add a currency surcharge to the price of the tour.

#### **Refund/Cancellation Policy:**

All cancellations must be in writing. The date of postmark will determine the amount of refund due. Refunds are based on the number of days prior to departure date. From the time of deposit to 99 days before departure a \$100 administrative fee plus any airfare penalties will be assessed. From 99-31 days, a \$300 cancellation penalty plus lost airfare deposits and any unrecoverable deposits to ground suppliers will be assessed. Airline tickets once purchased are nonrefundable. Anyone canceling less than 30 days prior to departure will receive **no refund**.
