Day 1: Friday, October 9, 2026 • Depart USA

We begin our pilgrimage with a flight to Tel Aviv.

Day 2: Saturday, October 10, 2026 • Arrival in Tel Aviv

Upon our arrival in Tel Aviv's our Israeli host assists us with the transfer of our luggage. We board a motor coach and drive along the shores of the Mediterranean Sea to our hotel. Time permitting, we take a walking tour of Joppa/Jaffa, the ancient seaport mentioned in the biblical narratives of Jonah and the whale, and Solomon's import of the cedars of Lebanon. It is also where Simon the Tanner lived, and Peter stayed during his missionary activities. **D**

Day 3: Sunday, October 11, 2026 • Galilee Region

After breakfast, we board our coach and drive along the coast to **Caesarea Maritima**, built by King Herod the Great in 22 B.C. It was here that Pontius Pilate lived and where the Gospel was first brought to the Gentiles. We visit the Roman Theater, the Roman Aqueduct, and the Herodian Port. We drive by Mount Carmel where Elijah confronted the prophets of Baal. We continue to **Megiddo**, the Chariot City for Solomon and Ahab. Here we explore the vast archaeological remains of this ancient city. We

end our day with a **boat ride across the Sea of Galilee** and stop to see the **2000-year-old Jesus boat**. **B/D**

Day 4: Monday, October 12, 2026 • Galilee Region

Our day begins in Nazareth with visits to the Church of the Annunciation, Mary's well, and **Nazareth Village**. We stop at Mount Precipice, where the Nazarenes sought to throw Jesus off the cliff (Lk. 4:16–30), then drive around the Sea of Galilee past Magdala, home of Mary Magdalene. We explore the 2,000-year-old remains of **Capernaum** (Lk. 4:31–37), and stand in what is left of the synagogue in which our Lord ministered. We see Peter's house, and visit **Tabgha**, commemorating the feeding of the 5,000 (Lk. 9); Mensa Christi, where the Lord appeared to the disciples after the resurrection (Jn. 21); and the Church of Peter's Primacy. We stop at **Chorazim** and Mount of the Beatitudes, where Jesus gave the Sermon on the Mount. We end the day in a time of spiritual blessing as we stop at Yardenit, the famous baptismal site on the Jordan River, where we are invited to touch the water. **B/D**

Day 5: Tuesday, October 13, 2026 • Galilee Region

Today we drive to **Caesarea Philippi** (Banias), a source of the Jordan River, where Jesus asked, "Who do people say the Son of Man is?" and foretold His journey to Jerusalem and crucifixion (Mt. 16:13–23). At **Tel Dan**, once called Laish, we see where the tribe of Dan lived and where King Jeroboam introduced idolatry by setting up a golden calf (1 Kgs. 12:25–33). We reflect on the significance of the Road to Damascus, then continue to the Golan Heights to recall the fierce battles of the Six Day War and the Valley of the Tears. We enjoy the snowcapped peak of Mount Hermon, the highest peak in the Middle East. At **Gamla**, we explore remains of a 1st-century town and synagogue where Jesus likely preached, along with its beautiful waterfall, and soaring vultures and eagles. We visit Bethsaida before returning to our Galilee hotel for dinner and overnight. **B/D**

Day 6: Wednesday, October 14, 2026 • Dead Sea

We begin at **Gideon Spring** where Gideon chose his army to fight the Midianites. We continue to the **Tel of Bet Shean**, where the bodies of King Saul and his sons hung from the city gates (I Sam. 31), and spend time at the luxurious Roman city of Bet Shean. Passing through the Judean Wilderness by Jericho, we head to **Qumran** to view Cave #4, which held the largest number of scrolls. Time permitting, we visit **En Gedi** to recall David's encounter with King Saul. We end the day at the Dead Sea with a chance to swim and float before dinner and overnight in the area. **B/D**

Day 7: Thursday, October 15, 2026 • Jerusalem

We visit **Masada**, the famous stronghold where the Jewish people held out while under attack from the Roman Army. We rise to the



top by cable car and see remnants of the city on the top. We drive through the Elah Valley where David faced Goliath (1 Sam. 22) and walk along the Road to Emmaus. We continue to Jerusalem for dinner and our hotel for next 5 nights. **B/D**

Day 8: Friday, October 16, 2026 • Jerusalem

Today we travel to **Shilo**, the ancient home of the Ark of the Covenant, then drive through the Samaritan mountains to Jerusalem. We visit the **Israel Museum** including the Temple Model and the Shrine of the Book, and end the day at the Western (Wailing) Wall, Judaism's most holy site. **B/D**

Day 9: Saturday, October 17, 2026 • Jerusalem

Our day begins at Mt. Zion, where we sing praises in the Upper Room (Lk. 22:7-38), view the traditional tomb of King David, and proceed to St. Peter Gallicantu, Caiaphas the High Priest's house (Jn. 18). Here we walk through some of the ancient rooms. At **Herodium** we view the tomb of Herod the Great. We have lunch with local Christians We see the **Shepherd's Fields** and explore **Bethlehem**, including a visit to the **Church of the Nativity**. **B/L/D**

Day 10: Sunday, October 18, 2026 • Jerusalem

We drive to the Mount of Olives for panoramic views of the Old City and Kidron Valley, then walk down the Palm Sunday Way to the Garden of Gethsemane, where Jesus prayed while the disciples slept. We stop at Dominus Flevit, and the Tear Drop Church. We visit the Bazaar of the Old City and Cardo before continuing our day at **Yad Vashem**, a museum dedicated to the Holocaust. The Valley of the Lost Communities and the Righteous Alley are home to trees planted in honor of people such as Oscar Schindler, who risked their lives to save Jewish people during World War II. **B/D**

Day 11: Monday, October 19, 2026 • Jerusalem

Our final day includes a visit to the **South Steps** where the Rabbi taught, the Pools of Siloam, **Hezekiah's Tunnel**, Warren's Shaft and David's Palace. Entering the Old City through the Lion's Gate, we walk parts of the Via Dolorosa past Zion Monastery, continue to **Ecce Homo** (site of Jesus' scourging) and see an authentic Roman pavement at the Antonia Fortification. We visit Saint Anne's Church, and the Pool of Bethesda, then stroll through the colorful Arab Bazaar where the sounds and smells of the Middle East come alive. Our walk continues to the **Church of the Holy Sepulcher, ending at Calvary and the Garden Tomb**. This evening includes a very special communion service and a closing session. We enjoy a farewell dinner before we head to the airport for our early morning flight home. **B/D**

Day 12: Tuesday, October 20, 2026 • Return

We board our plane for our very early morning flight home.

Payment Schedule:

A deposit of \$750 is due with registration. Final payment is due 100 days prior to departure date. Invoice will be sent out prior to final payment. *Early registration is encouraged.*

Currency:

Currency exchange rates fluctuate constantly. In the event of a significant drop in the value of the dollar, we reserve the right to add a currency surcharge to the price of the tour.

Refund/Cancellation Policy:

All cancellations must be in writing. The date of postmark will determine the amount of refund due. Refunds are based on the number of days prior to departure date. From the time of deposit to 120 days before departure a \$100 administrative fee plus any airfare penalties will be assessed. From 119-46 days, a \$400 cancellation penalty plus lost airfare deposits and any unrecoverable deposits to ground suppliers will be assessed. Airline tickets once purchased are nonrefundable. Anyone 45 days or less prior to departure will receive NO REFUND.
