Day 1: June 16, 2018 • Depart USA

Today our Asian Adventure begins as we board our overnight flight to Hong Kong. Think of Mickey and Minnie and all your Disney friends as you sleep while we cross the Pacific Ocean.

Day 2: June 17, 2018 • Hong Kong

Watch the lights of the city as we approach Hong Kong late in the evening. After customs we transfer to the hotel for check-in and a snack.

Day 3: June 18, 2018 • Hong Kong

Hong Kong consists of the mainland Kowloon, Hong Kong Island, and hundreds of smaller out islands. We explore the city on foot, by ferry, trolley, escalator and tram. You discover that although this former British territory has been part of China for 20 years, it maintains much of its entrepreneurial spirit. Among the highlights are Victoria Peak, Hong Kong Park, the Star Ferry, Kowloon backstreets, and temples. We end the evening with dinner and a visit to the Symphony of Lights show on Victoria Harbour. For those wishing to extend their evening we enjoy a visit to the Kowloon Night Market, a short distance from the hotel. **B, D**

Day 4: June 19, 2018 • Hong Kong Disneyland

We head to Lantau, the largest of Hong Kong's outlying islands. We'll start with a visit to the Tian Tan, affectionately called the Big Buddha, sitting on amid the lush vegetation at the top of the mountain. From the statue, we'll get a perspective of the entire

country, and an overview of the Disneyland Park complex. That's our next destination, where we'll have the rest of the day to enjoy the rides, attractions, shows and more at the iconic park. It will all seem very familiar, but with a unique Asian flavor. We'll be staying at the resort overnight, so you can make your own way back at your convenience. **B**

Day 5: June 20, 2018 • Hong Kong Disneyland

The hotel chefs prepare a special dim sum brunch for us this morning. If you missed something at the park yesterday, you have time to catch it today with a second day at Disneyland. You might want to check out the gardens or promenade. Don't miss the evening light show. **B**

Day 6: June 21, 2018 • Hong Kong to Shanghai

Breakfast is on your own this morning. We transfer to the airport for a 3 hour flight to Shanghai. We'll check into our hotel and have dinner at the Bund before we take a River cruise to see Shanghai lit up at night. **D**

Day 7: June 22, 2018 • Shanghai Disney

See Disney's newest park with a full day of fun at the park. The Shanghai Disneyland Resort opened in June of 2016 on the outskirts of the city. After breakfast, we'll travel together to the park for a full day of fun. In addition to the park, you may also want to visit the Disneytown shopping area next door, or Wishing Star park, a green oasis in crowded Shanghai. We'll meet up at the end of the day and return to our hotel in

downtown Shanghai. **B**

Day 8: June 23, 2018 • Shanghai

Our guide will take us on a full day sightseeing tour of Shanghai, including the quays, Circus World and neighborhoods. We have dinner at before heading back to the hotel for the night. **B, D**

Day 9: June 24, 2018 • Shanghai to Tokyo

Our morning flight takes us to Tokyo, where our Japanese guide shows us the city. We see the Imperial Palace and Meiji Shrine, Ginza shopping district, and other unique corners of the city where ancient traditions mingle with modern-day technology. We visit the Kabuki Theater and have dinner as a group to experience a variety of Japanese specialties. We transfer to our Disney area hotel this evening for an early entrance to the park in the morning. **B, D**

Day 10: June 25, 2018 • Tokyo Disney

We have all day to enjoy the seven themed areas of the first international Disneyland Park. Opened in 1983, the park has been refined over the years to cater to the desires of both Japanese and international guests. You'll find plenty of familiar faces, rides and attractions, but you'll also find a Japanese flavor to the offerings. Start with breakfast at the Center Street coffeehouse, then opt for a green tea ice cream, before dining on Cajun, Chinese, or Burgers for dinner. There are stage shows to drop in on, parades, and the special night time light show that is a must see. You may return to our Disney Resort Hotel at your convenience.

Day 11: June 26, 2018 • Tokyo Disney

Your second day ticket lets you catch up on the attractions you've missed, or revisit your favorites. You might also want to make time to take a show or character meet and greet, or shop for only in Japan Disney items. Our final dinner is at the park before the night parade and fireworks. **D**

Day 12: June 27, 2017 • Return

Leaving the Disney fantasy is never easy, but we are returning home today. Crossing the International Date Line, our flight arrives into Chicago several hours before our departure time. How's that for "magic"?

However, prior to the issuance of a ticket, airlines may (and regularly do) impose fuel, tax, or security surcharges. In the event a surcharge is imposed after Ed-Ventures has received a final payment, Ed-Ventures will send an additional invoice for the surcharge amount. Early registration is encouraged.

Currency:

Currency exchange rates fluctuate constantly. In the event of a significant drop in the value of the dollar, we reserve the right to add a currency surcharge to the price of the tour.

Refund/Cancellation Policy:

All cancellations must be in writing. The date of postmark will determine the amount of refund due. Refunds are based on the number of days prior to departure date. From the time of deposit to 99 days before departure a \$100 administrative fee plus any airfare penalties will be assessed. From 99-14 days, a \$300 cancellation penalty plus lost airfare deposits and any unrecoverable deposits to ground suppliers will be assessed. Airline tickets once purchased are nonrefundable. Anyone canceling less than 14 days prior to departure will receive **no refund**.

Purchase of health, baggage, and trip cancellation/interruption insurance is strongly recommended.
