Pompeii

Day 1: Friday, September 9, 2022 • Depart

Our adventure starts today as we depart the USA on our scheduled flight to Rome, Italy.

Day 2: Saturday, September 10, 2022 • Rome

On arrival in the Eternal City, we see the glories of the Roman Empire. We become acquainted with a city that, along with Greece, had a strong influence on Western civilization. Our tour includes a visit to the Capitoline Hill area, from which we view the Roman Forum. We also see the Colosseum, Trevi Fountain, the Spanish Steps and much more. With a better understanding of Roman history and culture, we drive to our hotel and have time to relax before dinner. **B/D**

Day 3: Sunday, September 11, 2022 • Rome

Today we drive through the beautiful Italian countryside to Pompeii. Mount Vesuvius is an archaeological treasure trove and an insight into the ancient world. A local guide will take us through the ruins of Pompeii with explanations of how the city was before being destroyed by the volcano. **B/D**

Day 4: Monday, September 12, 2022 • Rome

This morning we visit Vatican City and St. Peter's Cathedral, home of the Roman Catholic Church and the largest cathedral in the world. Also included is a tour of the Vatican Museum and the Sistine Chapel. We have free time in the afternoon to explore other famous sights, including the Pantheon, a former pagan temple from AD 125 that is still the best-preserved building of ancient Rome. Tonight, we enjoy dinner at a Roman restaurant. **B/D**

Day 5: Tuesday, September 13, 2022 • Rome

We enjoy a free day to explore Rome at leisure. **B**

Day 6: Wednesday, September 14, 2022 • Napflion

We check out of our hotel this morning and transfer to Rome Airport for our flight to Athens. On arrival in Greece, we board our coach and travel to Corinth. We tour the archeological site of Ancient Corinth, with its Greek and Roman ruins. Our day continues with a visit to see the ruins of the palace Mycenae and the Tomb of Clytemnestra. After lunch in the nearby town of Mykínes, we drive to Epidavros, whose famous 4th-century BC theatre has near perfect acoustics. Our last destination today, is the resort town of Návplio with its well-preserved old town. There will be an opportunity to “volta” (take a stroll) along the cobblestone streets with the locals this evening. **B/D**

Day 7: Thursday, September 15, 2022 • Ancient Olympia

After breakfast, we travel to Ancient Olympia, home of the first Olympic Games. Our walking tour takes us to where the early athletes trained and competed, as well as to the site where the Olympic flame is still lit prior to the Summer and Winter Olympic Games. Nearby, we visit the Archaeological Museum of Olympia and see artifacts recovered from the site. After lunch on our own, we enjoy time in town to shop or perhaps relax at an outdoor café. **B/D**

Day 8: Friday, September 16, 2022 • Aráchova

Today we drive across the impressive Charilaos Trikoupis Bridge, which spans the Gulf of Corinth, to return to the Greek mainland. In the afternoon, we visit Delphi, a religious site that the Ancient Greeks considered the center of the world. Our tour includes the Sanctuary of Apollo, the Athenian Treasury and the Delphi Museum, with its most famous resident: a bronze charioteer from 470 BC. Tonight, we relax at our hotel in nearby Aráchova, a village on the southern slope of Mount Parnassós. **B/D**

Day 9: Saturday, September 17, 2022 • Athens

We return to Athens today. On arrival at the city center, a short walk takes us to the New Acropolis Museum, built in 2009 at the bottom of the Acropolis. Our tour of the museum introduces us to Greek culture, mythology, politics and religion. Time permitting, we stroll through the Pláka, the old, historical neighborhood of Athens, where we enjoy the sights and sounds of this ancient city. Dinner is at our hotel tonight. **B/D**

Day 10: Sunday, September 18, 2022 • Athens

After breakfast, we transfer to the Acropolis, where our tour manager introduces us to the Parthenon, the Propylaia, the Erechtheion and the temple of Athena Nike, iconic landmarks of Athens' skyline. We continue our exploration of the Greek capital on a panoramic city tour that brings us past the Temple of Zeus, the Panathenic Stadium, Síndagma (Constitution) Square



and the Roman Agora. We have free time this afternoon to explore more of the museums, markets, and shopping on the Pláka and Monastiráki Square. **B/D**

Day 11: Monday, September 19, 2022 • Return

Those of us returning to the U.S. today are transferred to the airport for our international flight home. **B**

Day 11: Monday, September 19, 2022 • Santorini

The rest of us head to the port where we board a ferry bound for the beautiful island of Santorini. On arrival we transfer to our hotel where we relax until dinner time. **B/D**

Day 12: Tuesday, September 20, 2022 • Santorini

Today we enjoy a guided tour of the island of Santorini including the beautiful black and red beach, and the traditional villages Fira and Oia. In the afternoon we enjoy a wine tasting at a local vineyard. The evening is free to explore or to watch the sunset in Oia. **B**

Day 13: Wednesday, September 21, 2022 • Santorini

Our last day is free to enjoy as we wish. Options include hiking, perusing shops, or lounging by the water. We reconvene this evening for a final dinner together. **B/D**

Day 14: Thursday, September 22, 2022 • Return

We transfer to Santorini airport for our early morning flight back to the U.S. **B**

Payment Schedule:

A deposit of \$500 per person is due with reservation. Final payment is due 100 days prior to departure date. Invoice will be sent out prior to final payment. Passengers may add after this date subject to air and land availability. Generally airlines do not increase the price of a ticket after it has been contracted. However, prior to the issuance of a ticket, airlines may (and regularly do) impose fuel, tax, or security surcharges. In the event a surcharge is imposed after final payment, an additional invoice will be sent for the surcharge amount. Early registration is encouraged.

Currency:

Currency exchange rates fluctuate constantly. In the event of a significant drop in the value of the dollar, we reserve the right to add a currency surcharge to the price of the tour.

Refund/Cancellation Policy:

All cancellations must be in writing. The date of postmark will determine the amount of refund due. Refunds are based on the number of days prior to departure date. From the time of deposit to 120 days before departure a \$100 administrative fee plus any airfare penalties will be assessed. From 119-31 days, a \$300 cancellation penalty plus lost airfare deposits and any unrecoverable deposits to ground suppliers will be assessed. Airline tickets once purchased are nonrefundable. Anyone canceling less than 30 days prior to departure will receive **no refund**.

Purchase of health, baggage, and trip cancellation/interruption insurance is strongly recommended.
