**Day 1: Monday, Sept. 6, 2021 • Departure**

We depart the US late this afternoon for our transatlantic flight to Reykjavik, Iceland. This short flight gets us excited for the adventure ahead.

**Day 2: Tuesday, Sept. 7, 2021 • Welcome to Iceland**

On arrival, we transfer from Keflavik Airport to Icelandair Hotel Natura in Reykjavik where we spend the night. There is free time to explore Iceland's capital on your own.

**Day 3: Wednesday, Sept. 8, 2021 • Volcano Crater, Seals, Fjords & Mountains**

This morning we meet our tour guide and depart from the Hotel. We travel west, passing the town of Borgarnes and climb the Grábrók volcano crater. In the afternoon, we visit a natural history & seal museum in Hvammstangi, a small fishing village in Northwest Iceland. After the museum we stroll around the local harbour. Further north we stop at the turf church of Víðimýri which has been extensively restored to its original form and is widely considered one of the purest and most beautiful examples of traditional Icelandic architecture. We continue along scenic fjord landscape and over several mountain passes until we reach Akureyri, the capital of North Iceland. Our overnight location is at the Icelandair Hotel Akureyri. **B, D**

**Day 4: Thursday, Sept. 9, 2021 • The Capital of North Iceland, Lake Mývatn & Geothermal Baths**

In the morning we explore Akureyri, a charming town of 17,000 inhabitants. We visit the botanical garden and enjoy the panoramic view over Eyjafjörður fjord. In the afternoon we travel to an important spot in Iceland's history, Goðafoss, the waterfalls of the gods. We continue to Lake Mývatn which is known for its geological wonders and active bird life during summer. Our next stop is the bizarre lava formations at Kálfaströnd followed by a walk around the many pseudo craters before ending an exciting day with a relaxing soak at Mývatn Nature Baths. The baths contain a unique blend of minerals, silicates and geothermal micro-organisms – a soothing combination for skin and spirit alike. We overnight at the Hotel Reynihlið. **B, D**

**Day 5: Friday, Sept. 10, 2021 • Lava Labyrinth, Hot Springs & Travel East**

In the morning we hike in a lava labyrinth at Dimmuborgir, "the dark castles", hoping to get a glimpse of the trolls who are said to live there. After lunch, on our own, we visit the hot spring area of Námaskarð with bubbling mud pools and steaming solfataras. We head through the uninhabited highlands and moonlike surrounding to East Iceland. With some luck we might spot an Arctic fox or a reindeer. We check into our hotel for overnight. **B, D**

**Day 6: Saturday, Sept. 11, 2021 • Fjords, Glacier and Ice**

It's a day to admire the dramatic fjord landscape and its tiny fishing villages at the end of twisty roads in the East Fjords. On route we visit an interesting stone and mineral collection. In the afternoon we see Vatnajökull – Europe's biggest glacier that is visible all-over Southeast Iceland. Past the town of Höfn, we stop at Jökulsárlón, a glacial lagoon filled with floating icebergs. We explore the extraordinary site and might even see seals swimming in the arctic waters. We can walk on the black sandy beach where large icebergs get stranded. Continuing along the southern part of the glacier Vatnajökull, we spend time at Vatnajökull National Park, Europe's largest national park, which has Iceland's highest mountains, an alpine environment, and Europe's largest glacier. We overnight at the Icelandair Hotel Kirkjubæjarklaustur. **B, D**

**Day 7: Sunday, Sept. 12, 2021 • South Coast**

A beautiful drive with many natural wonders awaits us today as we head across the Eldhraun lava field. We cross the sandy desert of the south coast, overlooked by mountainous cliffs, glaciers and waterfalls and stroll along the black lava beach of Reynisfjara near Vík. In the small village of Skógar, we view the Skógafoss waterfall, which is 60 meters high and is one of the most impressive waterfalls in the country. Further west, we stop at the Eyjafjallajökull Information Center and learn about living next to a glacier and an active volcano before continuing to the high but narrow Seljalandsfoss waterfall, which plunges over the mountain. There is an interesting trail that goes behind the fall – if you are prepared to get wet! We overnight at the Icelandair Hotel Flúðir. **B, D**

**Day 8: Monday, Sept. 13, 2021 • Icelandic Horses & Golden Circle**

We explore classics today, as we travel the route of the Golden Circle sights. We start the day at Friðheimar, where we learn about the Icelandic horse, its special qualities and history and pay a visit to a geothermal greenhouse. Later on, we see steam from the Geysir geothermal fields as we arrive. There are a variety of hot springs and bubbling pools. The original geyser is now dormant but has been replaced by Strokkur "the Churn" which erupts at 5-10-minute intervals. We continue to Gullfoss, "the golden falls", which is a double waterfall that tumbles 34 meters into the Hvítá river and attracts travelers all year round. Traveling inland we visit Thingvellir National Park, a UNESCO World Heritage site. As we return to Reykjavik, we take a short city tour to show highlights of the world's northernmost capital. We overnight at the Icelandair Hotel Natura. **B, D**

**Day 9: Tuesday, Sept. 14, 2021 • Departure Home or Extension**

We transfer to Keflavik Airport for our flight back to USA or on to Scotland. **B**

## Scotland Extension

### Day 9: Tuesday, Sept. 14, 2021 • Glasgow Area

This morning we board our flight and continue to Glasgow. Upon arrival we meet our Scottish guide who introduces us to the city including Glasgow Cathedral, George Square, The People's Palace, City Chambers, Necropolis (a memorial Victorian cemetery where 50,000 people are buried) and explore the Kelvingrove Art Gallery and Museum. The remainder of the afternoon is free to explore. We have dinner and overnight. **B, D**

### Day 10: Wednesday, Sept. 15, 2021 – Inverness Area

Today we head north along Loch Lomond and Glencoe to Fort William, where we can view Ben Nevis. At 4,406 feet, it is the highest mountain in the British Isles, and the vistas are breathtaking. We continue to Fort Augustus, located at the southern edge of **Loch Ness**, where we board a vessel and do our own searching for Nessie, the friendly, but elusive, resident monster. **B, D**

### Day 11: Thursday, Sept. 16, 2021 – Edinburgh

A full day of sightseeing and exploration awaits us. We begin by discovering the area of the savage clans and roving barbarians, including a visit to the **Culloden Battlefield**. We learn about the Jacobite movement, the rise and demise of the clan system, local homes and battlegrounds, and discover many clues to the Celtic and non-Celtic ancestors of the Highlanders. Then, we drive through the Grampian Mountains in the Highlands and venture down into the Cairngorms National Park, the largest in Britain. It covers almost 2,300 miles of beautiful and unspoiled countryside including wild moorlands, soaring mountain peaks, granite Ice Age glacier heaves, and spectacular valleys, rivers and lochs (lakes) as well as a huge variety of wildlife. We take a break to enjoy **Afternoon Tea**. We arrive in Edinburgh in time for dinner. **B, D**

### Day 12: Friday, Sept. 17, 2021 – Edinburgh

This morning we enjoy a **panoramic tour of Edinburgh**, a beautiful city, often referred to as the "Athens of the North!" Highlights will include the Walter Scott Monument, the elegant Prince's Street, architectural wonders, plus much more! We have an inside tour of **Edinburgh Castle**, with its foreboding ramparts and walls, amazing city views, Crown jewels, and the siege gun, Mon's Meg. The afternoon is open for options, an opportunity to visit museums or Queen Elizabeth II's Yacht "Britannia", explore botanical gardens or the zoo, or perhaps shop for that special "Scottish Tweed." **B, D**

### Day 13: Saturday, Sept. 18, 2021 – Return

Today we drive to Glasgow for our return flight home.

However, prior to the issuance of a ticket, airlines may (and regularly do) impose fuel, tax, or security surcharges. In the event a surcharge is imposed after Ed-Ventures has received a final payment, Ed-Ventures will send an additional invoice for the surcharge amount. Early registration is encouraged.

### Currency:

Currency exchange rates fluctuate constantly. In the event of a significant drop in the value of the dollar, we reserve the right to add a currency surcharge to the price of the tour.

### Refund/Cancellation Policy:

All cancellations must be in writing. The date of postmark will determine the amount of refund due. Refunds are based on the number of days prior to departure date. From the time of deposit to 99 days before departure a \$100 administrative fee plus any airfare penalties will be assessed. From Final payment due date until 31 days before departure, a \$500 cancellation penalty plus lost airfare deposits and any unrecoverable deposits to ground suppliers will be assessed. Airline tickets once purchased are nonrefundable. Anyone canceling less than 30 days prior to departure will receive **no refund**.


