**Day 1: Friday, February 7, 2025 • Departure** Our journey begins as we board our international flight bound for New Delhi, India. **Inflight meals** 

Day 2: Saturday, February 8, 2025 • Arrive in New Dehli

Upon arrival, we will be met by a representative at the airport, who will escort us to the hotel.

## Day 3: Sunday, February 9, 2025 • Delhi

Following breakfast, we drive past and learn about the **Red Fort**, a UNESO World Heritage Site, in the Old Delhi neighborhood of Delhi. Opposite the fort are the black and white onion dome and minarets of the **Jama Masjid**, the most elegant mosque in India. We visit **Raj Ghat**, a memorial complex, where a black marble platform was raised to mark the spot where Mahatma Gandhi was cremated in 1948. We drive through the old city and take a **rickshaw ride in Old Delhi**. This afternoon we drive past and photograph **Rashtrapati Bhavan**, the **Presidential Palace**, and the **Secretariat Building** which is the center of all government activity in India. We continue to the **World War I memorial Arch**, the **India Gate**, and the **High Court Building**. We visit **Humayun's Tomb** built in 1565 AD by his grieving widow, Haji Begum. Overnight in Delhi. **B** 

## Day 4: Monday, February 10, 2025 • Agra

We depart for Agra and visit **Qutab Minar**, a UNESCO World Heritage Site. This monument is the tallest minaret in the world made of bricks. The Minar is surrounded by several historically significant monuments of the Qutab complex, including Quwat-ul-Islam Mosque and the much older Iron Pillar of Delhi. We arrive in Agra and check in to our hotel. Dinner is on your own. **B** 

## Day 5: Tuesday, February 11, 2025 • Agra

We wake early to see the **Taj-Mahal** (UNESCO World Heritage Site) at sunrise. With its incredible lacy white grandeur, the Taj Mahal is perhaps the most perfect architectural monument in the world. We return to the hotel for breakfast and later visit **Agra Fort**, designated as a UNESCO World Heritage Site because of its importance during the Mughal Dynasty. We return to our hotel and overnight in Agra. **B** 

# Day 6: Wednesday, February 12, 2025 • Kalakho

We drive to Kalakho. Mahatma Gandhi once wrote, "If you want to experience the soul of India, then you must go to her



*villages.*" **Gadoli** is one of those villages. We experience village life off the normal tourist path. We visit the **Abhaneri Step Wells** that were built in the 8<sup>th</sup> and 9<sup>th</sup> centuries. BBC Travel has called it one of the 7 Unknown Architectural Wonders in the World. We check into our hotel for overnight. **B/L/D** 

# Day 7: Thursday, February 13, 2025 • Kalakho

We explore nearby villages using small carts pulled by camels enabling us to understand the life of local villagers. Visit their traditional mud huts and interact with villagers as they follow daily activities in their homes. This afternoon we enjoy free time. We are welcome to join in learning how to play cricket on the retreat grounds. In the late afternoon, there will be an opportunity to go on a challenging nature hike in the nearby hills. Overnight in Kalakho. **B/L/D** 

# Day 8: Friday, February 14, 2025 • Ranthambore

We drive to Ranthambore to see the fascinating jungles that are famous for rare species of tiger. We check in to the hotel where we eat lunch. After lunch, we visit **Dhonk**, a Women's Cooperative that provides sustainable employment to expoachers and villagers and generates income for the community. The profits go back into supporting tiger conservation. Overnight in Ranthambore. B/L/D

# Day 9: Saturday, February 15, 2025 • Ranthambore


We enter **Ranthambore National Park**, one of the biggest and most renowned national parks in Northern India. We take two jeep safari's today in the park, one in the early morning and the other in the late afternoon to explore the park and see the wildlife. We return to the hotel for overnight. **B/L/D** 

# Day 10: Sunday, February 16, 2025 • Jaipur

We drive to **Jaipur**. It is often referred to as the "Pink City" because of the extensive use of locally abundant pink plastered stone that was painted in honor of a visit of the royal consort of Queen Victoria. We check in to our hotel for overnight. **B** 

# Day 11: Monday, February 17, 2025 • Jaipur

Today we visit **Amer Fort**, a UNESCO World Heritage Site. Located high on a hill, we ride an elephant to reach it. We visit **City Palace**, a royal residence that houses the Chandra Mahal, Shri Govind Dev Temple, and the City Palace Museum. We visit **Jantar Mantar**, the largest and best preserved of the five observatories built by Jai Singh II



throughout the country. It houses nineteen astronomical instruments built by Sawai Jai Singh and features the world's largest stone sundial and is a UNESCO World Heritage Site. It is still used today. We also visit **Hawa Mahal**. a prominent landmark in Jaipur. Overnight in Jaipur. **B** 

## Day 12: Tuesday, February 18, 2025 • Departure

After breakfast we drive to Delhi. Depending on flight times, we may have time for some shopping. We have dinner at a hotel near the airport. Two wash and change rooms will be provided for the group before transfer to the airport for flights home. **B**

A deposit of \$500 per person is due with reservation. Final payment is due 90 days prior to departure date. (Nov. 9, 2024) Invoice will be sent out prior to final payment. Passengers may add after this date subject to air and land availability. Generally airlines do not increase the price of a ticket after it has been contracted. However, prior to the issuance of a ticket, airlines may (and regularly do) impose fuel, tax, or security surcharges. In the event a surcharge is imposed after Ed-Ventures has received a final payment, Ed-Ventures will send an additional invoice for the surcharge amount. Early registration is encouraged.

#### **Currency:**

Currency exchange rates fluctuate constantly. In the event of a significant drop in the value of the dollar, we reserve the right to add a currency surcharge to the price of the tour.

#### **Refund/Cancellation Policy:**

All cancellations must be in writing. The date of postmark will determine the amount of refund due. Refunds are based on the number of days prior to departure date. From the time of deposit to 120 days before departure a \$100/person administrative fee plus any airfare & land penalties will be assessed. From 119-31 days, a \$300/person cancellation penalty plus lost airfare deposits and any unrecoverable deposits to ground suppliers will be assessed. Airline tickets once purchased are nonrefundable Anyone canceling 30 days or less prior to departure will receive **no refund**.

Purchase of health, baggage, and trip cancellation/ interruption insurance is strongly recommended.
