#### Day 1: Friday, July 12, 2024 • Departure

Our journey begins as we board our international flight bound for Dublin, Ireland. **Inflight meals** 

#### Day 2: Saturday, July 13, 2024 • Dublin

Upon arrival in Dublin, we meet our driver and guide. A local guide joins us for a panoramic tour of Ireland's fair capital. We visit St. Patrick's Cathedral, home of Ireland's largest and most beautiful organ as well as memorials to Dean Jonathan Swift. We also visit the famed Trinity College founded in 1592 by England's Queen Elizabeth I. Of course, while at the college we see the Book of Kells, the ancient manuscript of the four gospels in Latin on vallum dating back to the year 800. We have dinner at our hotel. **D** 

#### Day 3: Sunday, July 14, 2024 • Dublin

This morning we attend Mass. Afterwards, regardless of how well we've behaved so far, we're going to jail! Yes, we spend some time behind bars at historic Kilmainham Gaol, one of the largest unoccupied prisons in Europe. Next, we unwind a bit during a tour of the Guinness Brewery Museum and Hop Store. After viewing the displays that chronicle a humble 200-year history of brewing at St James Gate, we finally have a chance for a taste. The rest of the afternoon is free to explore Dublin. Tonight, we celebrate our final evening in Dublin with dinner, dancing, singing and entertainment at the famous Abbey Tavern. **B**, **D** 

#### Day 4: Monday, July 15, 2024 • Cobh area

Our first stop today is the medieval city of Kilkenny. We walk



through St. Canice's Cathedral and admire the high crosses found in the cemetery, and the round tower adjacent to it. With a chance to appreciate the strength and charm of the Anglican influence, we visit the imposing fortress, Kilkenny Castle, and its lovely gardens. After some free time in Kilkenny, we head to Cobh for our overnight. **B** 

#### Day 5: Tuesday, July 16, 2024 • Killarney

This morning we visit the Queenstown Exhibit in Cobh. Between 1840 and 1950 over six million men, women and children emigrated from Ireland. The Queenstown Story is a museum about that wave of emigration, including the story of Annie Moore, the first emigrant to be processed at Ellis Island when it opened in 1892. There's also information on the Titanic, and the Lusitania, as well as the maritime history of Cork. Next, we visit the St. Colman's Cathedral. Later, we visit the Blarney Castle. Of course, we want to kiss the "Blarney Stone" and acquire the "gift of eloquence." We also visit the renowned Blarney Woolen Mills. We then continue to our hotel in Killarney. **B**, **D** 

#### Day 6: Wednesday, July 17, 2024 • Killarney

Today we travel on one of the most scenic roads in the world: the Ring of Kerry. Sights such as Ladies View, McGillycuddy's Reeks, Waterville and Cahersiveen come to life as we negotiate narrow, winding roads with stunning views. We return via the Killarney National Park with a jaunting cart ride and have the chance to view the area's lush woodlands, deep blue lakes, and varied wildlife. This evening is free to explore more of Killarney. **B** 







#### Day 7: Thursday, July 18, 2024 • Galway

Today we head to Galway where a local guide introduces us to the city's main attractions, including the vibrant Eyre Square, Salmon Weir Bridge and the Galway Cathedral, the last great building in Ireland to be built of natural stone. We have free time to explore Galway. **B** 

#### Day 8: Friday, July 19, 2024 • Limerick

We venture out via the Burren to see the Cliffs of Moher; dark, limestone cliffs that stretch for five miles dropping down to the raging, foaming sea! We head to Bunratty Castle to stroll in the Folk Park. A living reconstruction of the homes and lives of Ireland a century ago, we delight in the rural farmhouses, village shops and Bunratty House, all furnished as they were then. In the evening we are treated to a medieval banquet featuring wholesome food, music, song, and dance. **B**, **D** 

#### Day 9: Saturday, July 20, 2024 • Return

Regretfully, it's time to say "Slán agat" (Goodbye) and transfer to the Shannon Airport, where our international flight is waiting to return us to the USA. We return, however, with memories of lovely landscapes, verdant fields, fabulous castles, interesting pubs and people, enchanting music and most importantly, a wealth of new friends! Welcome home! **B**

All cancellations must be in writing. The date of postmark will determine the amount of refund due. Refunds are based on the number of days prior to departure date. From the time of deposit to 120 days before departure a \$100/person administrative fee plus any airfare & land penalties will be assessed. From 119-31 days, a \$300/person cancellation penalty plus lost airfare deposits and any unrecoverable deposits to ground suppliers will be assessed. Airline tickets once purchased are nonrefundable. Anyone canceling less than 30 days prior to departure will receive no refund. Please refer to the terms and conditions on your brochure for further information.

Purchase of health, baggage, and trip cancellation/interruption insurance is strongly recommended.
