### Day 1: Thursday, June 1, 2017 • Departure

Our tour begins this morning, with our departure to Lisbon, Portugal.

### Day 2: Friday, June 2, 2017 • Porto

Upon arrival at the Francisco de Sá Carneiro Airport, we meet our local guide and our coach. We make our way into the heart of Portugal's second-largest city, **Porto**! This riverside city has much to offer such as the historic Ribeira Square that looks out onto the River Douro, Gustave Eiffel's Ponte de Dom Luís amongst other exciting finds. Being the birthplace of port wine, a tour isn't complete until we **visit a local winery**. After checking into our hotel we enjoy free time to relax before enjoying dinner at the hotel. **D**

### Day 3: Saturday, June 3, 2017 • Lisbon

We proceed into the capital city of Portugal, where we enjoy a guided **panoramic tour**. We explore the charming Alfama District and visit the **Castelo de São Jorge** for an amazing view of the city and coastline. After checking into our hotel, we enjoy some free time this afternoon to do some shopping or visit the town. This evening we enjoy **dinner and traditional music** at one of Lisbon's Fado houses. **B, D**

### Day 4: Sunday, June 4, 2017 • Seville

On the way to Spain, we stop for lunch in Elvas, noted for a

16th century aqueduct that still supplies this market town with water. We cross the border near the Citadel of Badajoz. Upon arrival in Seville, the vibrant capital of Andalusia, we visit the **Alcázar** – an imposing 9th-century Mudéjar palace. Seville's Alcázar has been the home of Spanish kings for almost seven centuries and is still used today by the royal family, which makes it the oldest existing fortress still serving European royalty. **B, D**

### Day 5: Monday, June 5, 2017 • Seville

This morning we are treated to a **tour** of Seville. This city epitomizes the Andalusian culture, with its Roman and Moorish architecture, elaborate gardens, and unshakable belief in the good life. Our tour includes a visit to the great **Gothic Cathedral**, the third largest church in the world, where Christopher Columbus is believed to be entombed. We have the afternoon free to explore Seville's scenic neighborhoods and other sights on our own. After dinner we have the special treat of attending a **flamenco show**. Flamenco is the emotional and dramatic dance for which Seville is known. **B, D**

### Day 6: Tuesday, June 6, 2017 • Granada

Today we travel to Granada, where we **tour** the mighty **Alhambra** and its adjoining Generalife Gardens. The Alhambra was the last foothold of the Moors in Western

Europe, and is Spain's number one attraction. When one sees its grandeur, it becomes obvious why! **B, D**

**Day 7: Wednesday, June 7, 2017 • Toledo**

Today we continue on to Toledo, the walled fortress city and former capital of Spain. A **tour** of the city includes the massive **cathedral** which reflects the heart and history of the Spanish church, and **La Iglesia de Santo Tomé**, where we can admire one of El Greco's masterpieces. After our tour, we enjoy a little free time to explore Toledo on our own before enjoying dinner at our hotel. **B, D**

**Day 8: Thursday, June 8, 2017 • Madrid**

This morning we continue on to Madrid, where a local **guide** shows us the highlights of the city. We see the Plaza Mayor, the monument to Cervantes located in the Plaza de España, Retiro Park, la Puerta del Sol (the Times Square of Madrid), and the **Royal Palace**. We have the afternoon free to pursue individual interests. **B, D**

**Day 9: Friday, June 9, 2017 • Madrid**

We journey to the historic pueblo of Segovia, just outside of Madrid. Here we visit the impressive Roman Aqueduct, built in 50 BC. We also visit Segovia's idyllic **castle** and **cathedral**. The castle is of the late-medieval style, and anyone who is feeling ambitious may want to climb the 140 step spiral staircase to the top of the tower where you will be rewarded with a breath-taking view. On our way back to Madrid, we stop and see the **Valle de los Caídos**, Franco's powerful memorial to those who fought in the Spanish Civil War, and if time permits we see the **Escorial**, a massive complex that includes a monastery, a church and two palaces. **B, D**

**Day 10: Saturday, June 10, 2017 • Barcelona**

This morning we transfer to the railway station to catch our high speed train to Barcelona. We check into our hotel upon arrival and have some time to relax before trying some of the specialties of Cataluña at a local restaurant. **B, D**

**Day 11: Sunday, June 10, 2017 • Barcelona**

This morning a local city guide meets us at our hotel, and takes us on a panoramic tour of the city. We see such sites as the Olympic grounds, Parc Güell, Barrio Gótico, Las Ramblas, and Gaudi's unfinished masterpiece, La Sagrada Família. We also visit Montjuïc Park, Barcelona's largest recreation area, which overlooks the city and harbour. We then have the afternoon free in the city to explore more on our own. Tonight we get together for the last time and enjoy our farewell dinner at a local restaurant. **B, D**

**Day 12: Monday, June 11, 2017 • Return to U.S**

This morning we transfer to Barcelona airport for our return flights. We leave with memories of lovely landscapes, grand architecture, enchanting towns, fiery dance and rustic food – everything that embodies the passion of Portugal and Spain. **B**

However, prior to the issuance of a ticket, airlines may (and regularly do) impose fuel, tax, or security surcharges. In the event a surcharge is imposed after Ed-Ventures has received a final payment, Ed-Ventures will send an additional invoice for the surcharge amount. Early registration is encouraged.

**Currency:**

Currency exchange rates fluctuate constantly. In the event of a significant drop in the value of the dollar, we reserve the right to add a currency surcharge to the price of the tour.

**Refund/Cancellation Policy:**

All cancellations must be in writing. The date of postmark will determine the amount of refund due. Refunds are based on the number of days prior to departure date. From the time of deposit to 99 days before departure a \$100 administrative fee plus any airfare penalties will be assessed. From 99-14 days, a \$300 cancellation penalty plus lost airfare deposits and any unrecoverable deposits to ground suppliers will be assessed. Airline tickets once purchased are nonrefundable. Anyone canceling less than 14 days prior to departure will receive **no refund**.
