**Day 1: Sunday, September 17, 2023 • Depart USA**

We depart the USA on our overnight flight to Madrid, Spain.

**Day 2: Monday, September 18, 2023 • Arrive in Madrid – Overnight in Madrid**

We arrive in Madrid, the capital of Spain. After clearing customs and immigration, we meet our guide and take a tour of this cosmopolitan city. We learn about Madrid's important historic and artistic heritage and see some of the magnificent architecture from the baroque to the ultra-modern. We have some free time to visit one or two of the highlights, such as the world-famous Prado Art Museum, before meeting up again for dinner and a well-deserved good night's sleep. **D**

**Day 3: Tuesday, September 19, 2023 • Madrid to León**

After breakfast at the hotel, we transfer to León where we tour the city. **B, D**

**Day 4: Wednesday, September 20, 2023 • Sarria**

Today we make our way to Sarria. On arrival, we secure our pilgrim credentials. **B**

**Day 5: Thursday, September 21, 2023 • Sarria to Portomarin area**

*Walk from Sarria to Portomarin*  
(approx. 21 km or 12 mile)

We may run into some new pilgrims today, as we are just beyond the 100 km mark that makes your Camino de Santiago pilgrimage official and awards you the Compostela. Today's walk passes through many towns before ending in Portomarin. The most important landmark in the town is the old roman bridge, although the entire town is significant, as it was moved brick by brick to higher ground when a new dam was scheduled to flood the old town site. **B, D**

**Day 6: Friday, September 22, 2023 • Portomarin to Hospital de la Cruz area**

*Walk from Portomarin to Hospital de la Cruz*  
(approx. 13 km or 8 miles)

This is a short day of walking, although it is largely uphill.

There are several small villages along the route, and the Romanesque church in Castromaier which is worth a short visit. **B, L**

**Day 7: Saturday, September 23, 2023 • Hospital de la Cruz to Palais de Rei**

*Walk from Hospital de la Cruz to Palais de Rei*  
(approx. 12 km or 7 miles)

A day of delight! This short walk is mostly level and unchallenging, the perfect time to reflect on our intentions for this pilgrimage. **B**

**Day 8: Sunday, September 24, 2023 • Palais de Rei to Melide**

*Walk from Palais de Rei to Melide*  
(approx. 13 km or 8 miles)

This is a relatively easy walk, with many small towns along the route. It spends a good part of the day along major roads, though, so pay attention to your safety and surroundings. There is a beautiful 15th century church dedicated to San Pedro in Melida. The murals merit a stop to enjoy their messages and symbolism before settling into the hostel for the evening. **B, D**

**Day 9: Monday, September 25, 2023 • Melide to Arzuá**

*Walk from Melide to Arzuá*  
(approx. 15 km or 9 miles)

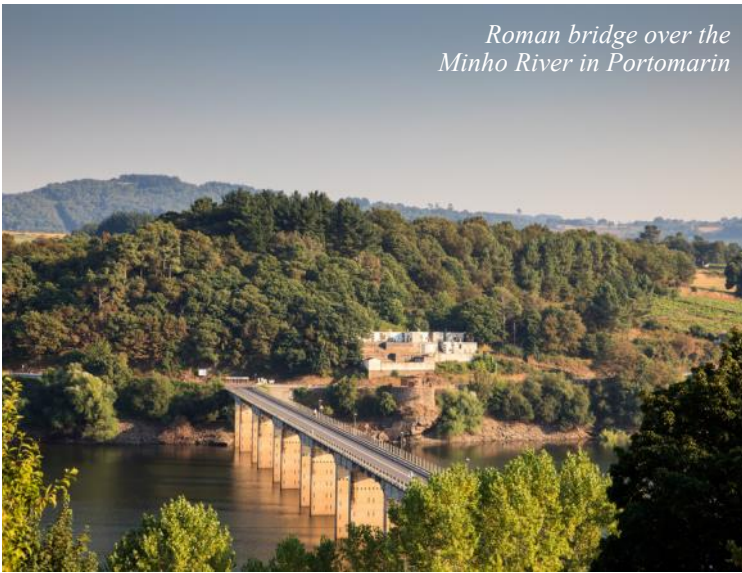
We may want to visit Melida's market before starting off this morning. The walk starts along quiet farmland before starting a rise into the town of Arzuá. **B**

**Day 10: Tuesday, September 26, 2023 • Arzuá to Pedrouzo**

*Walk from Arzuá to Pedrouzo*  
(approx. 21 km or 12 miles)

This final major stage takes us very close to Santiago. We are passing through many smaller villages and are sure to see a swelling of the numbers of pilgrims as the routes begin to converge. Tonight, we reflect on our journey before spending our last night on the route. **B**

**Day 11: Wednesday, September 27, 2023 •**

**Pedrouzo to Santiago de la Compostela**

*Walk from O Pedrouzo to Santiago;*  
*(approx. 21 km or 12 miles)*

We make our descent into Santiago de la Compostela this morning. We take a photo in front of the Pilgrim Monument at Monte de Gozo to commemorate our feat, before picking up our compestelas (certificates of accomplishment). The Old Town is a UNESCO designated World Culture Center. It has been a pilgrimage site since the 9th century, when a peasant saw a mysterious light emanating from a tomb and the burial site of St. James was discovered. We attend the Pilgrim's Mass at Noon at the Cathedral before checking into the hotel where dinner awaits us. **B, D**

**Day 12: Thursday, September 28, 2023 •**

**Santiago de la Compostela**

Morning city tour; tour of Cathedral and museum; sightseeing in town. Ride the Tourist Train. **B, D**

**Day 13: Friday, September 29, 2023 • Return to USA**

We board our flights for a safe return to the USA. **B**

A deposit of \$500 per person is due with reservation. Final payment is due June 9, 2023). Invoice will be sent out prior to final payment. Passengers may add after this date subject to air and land availability. Generally airlines do not increase the price of a ticket after it has been contracted. However, prior to the issuance of a ticket, airlines may (and regularly do) impose fuel, tax, or security surcharges. In the event a surcharge is imposed after Ed-Ventures has received a final payment, Ed-Ventures will send an additional invoice for the surcharge amount. Early registration is encouraged.

**Currency:**

Currency exchange rates fluctuate constantly. In the event of a significant drop in the value of the dollar, we reserve the right to add a currency surcharge to the price of the tour.

**Refund/Cancellation Policy:**

All cancellations must be in writing. The date of postmark will determine the amount of refund due. Refunds are based on the number of days prior to departure date. From the time of deposit to 100 days before departure a \$100 administrative fee plus any airfare penalties will be assessed. From 99-31 days, a \$300 cancellation penalty plus lost airfare deposits and any unrecoverable deposits to ground suppliers will be assessed. Airline tickets once purchased are nonrefundable. Anyone canceling less than 30 days prior to departure will receive **no refund**.

***Purchase of health, baggage, and trip cancellation/interruption insurance is strongly recommended.***
