*September 9-15, 2014*



## **Tuesday, September 9, 2014 • Departure**

Our tour begins this morning with our departure from the Minneapolis Airport en route to Keflavik International Airport, Iceland.

## **Wednesday, September 10, 2014 • Reykjavik**

Today we arrive at the Keflavik airport and after going through immigration, we will meet our driver and board our deluxe motor coach, we will travel to Reykjavik, the capital of Iceland. Once we reach Reykjavik we will enjoy a locally **guided city tour**, some of top attractions we will see include **Hallgrimskirkja Church**, **presidential residence at Bessastadir**, and the **fish markets in Hafnarfjorfur**. ## **Thursday, September 11, 2014 • Kirkjubaejarklaustur**

After breakfast this morning we will travel along the stunning south coast. Along the way you will see some of the most breathtaking waterfalls including the **Seljalandsfoss waterfall** which is one of Iceland's spectacular waterfalls. You will also see some spectacular **geothermals** along the drive to Kirkjubaejarklaustur where we will be staying the night. (B,D)

## **Friday, September 12, 2014 • Kirkjubaejarklaustur**

Today we will be going to see the **Skaftafell National Park** where we will see the **waterfall Svartifoss** along with some many species of birds and arctic foxes. We will next journey to the **Jokulsarlon Glacial Lagoon** where a cruise is optional, occasionally you can see seals in the lagoon as well as many different types of birds, but mostly the Arctic Tern and Great Skua. After the magnificent sights we see today we will travel back to Kirkjubaejarklaustur to stay the night. (B,D)

## **Saturday, September 13, 2014 • Reykjavik**

We will leave the Kirkjubaejarklaustur area today by traveling back along the South Coast. We will take the Golden Circle route back to Reykjavik. Along the Golden Circle route we will stop at the **Pingvellir National Park**, the **Gullfoss Waterfall**, and the geothermal active valley of **Haukadalur**, where we will see the **Geysir and Strokkur Geysers**. We will stay in Reykjavik for the next two nights. (B,D)

## **Sunday, September 14, 2014 • Reykjavik**

Today is a free day where you can choose from many different optional tours or you can see the sights in Reykjavik and do some shopping. (B,D)

## **Monday, September 15, 2014 – Return**

For some of us our travels must truly come to an end today. After packing our bags we board our coach and start out to the airport. En route, we stop for a final time at the famous, **Blue Lagoon** - reputed for its healing powers. We pause for a swim in the relaxing thermal waters and then continue to Keflavik Airport to catch our flight back to America. Those continuing to Scotland will enjoy dinner and a free evening in Keflavik before continuing on in the morning. (B)

Currency exchange rates fluctuate constantly. In the event of a significant drop in the value of the dollar, we reserve the right to add a currency surcharge to the price of the tour.

**Refund/Cancellation Policy:**

All cancellations must be in writing and the date of postmark will determine the amount of refund due. Refunds are based on the number of days prior to the departure date. From the time of deposit to 90 days before departure, a \$50 per person administrative fee and any lost airfare deposits will be assessed. From 89-46 days, a \$150 per person penalty plus any nonrefundable deposit to ground suppliers as well as penalties imposed by the airlines will be assessed. From 45-31 days, a \$200 per person penalty plus any nonrefundable deposit to ground suppliers as well as penalties imposed by the airlines will be assessed. From 30-15 days, a \$250 per person penalty plus any nonrefundable deposit to ground suppliers as well as penalties imposed by the airlines will be assessed. Airline tickets once issued are generally not refundable. Anyone canceling less than 14 days prior to departure will receive **no refund**.
